

What's Changed Amethyst Original Home Insurance Policy 2019

For UK home insurance policy wording reference: AMEO/0519/PW

The following document demonstrates any significant differences to the conditions of the policy and the cover between the 2018 policy wording, with a wording reference of AMEO/0118/PW, and the 2019 policy wording, with a wording reference of AMEO/0519/PW.

 - escape of oil from an oil tank unless you can provide evidence that the oil tank is less than 10 years old or that it is inspected annually by a qualified OFTEC engineer and certified as in good condition without the need for repair or replacement
- 9) The following exclusions have been added 'Section 3 Your Legal Liability to the Public Exclusions' (page 32):

What is not covered

- 4. Any liability:
 - arising as a result of escape of oil from an oil tank unless you can provide evidence that the oil tank is less
 than 10 years old or that it is inspected annually by a qualified OFTEC engineer and certified as in good
 condition without the need for repair or replacement
- 7. Liability arising out of **your** ownership, possession or use of any vehicle where any Road Traffic Act or similar legislation says that **you** must have motor liability insurance.
- 10) 'Data Protection Legislation' definition has been added to 'Section 5 Home Emergency' (page 34)
- 11) 'Privacy & Data Protection Notice' has been added to 'Section 5 Home Emergency Conditions' (page 38)
- 12) The insurer/underwriter under 'Section 6 Legal Expenses & Identity Theft' has been changed to AmTrust Europe Ltd.
